AIB Community €1 Million Fund Terms and Conditions for Nominators

Eligibility Criteria to nominate

1. To be eligible to enter each entrant must:
 - a) have a valid email address
 - b) be an individual not a company
 - c) must have the charity registration number of their chosen organisation

To nominate, the entrant (having complied with term 1 (a) to (c) inclusive) must complete the nomination form online on aibni.co.uk/community/community-Fund or aibgb.co.uk/community/community-fund

Nomination

The Fund is: AIB Community €1 Million Fund

The Fund Provider is: Allied Irish Banks, p.l.c. registered in Ireland. Registered no. 24173. Registered office: 10 Molesworth Street, Dublin 2. Allied Irish Banks, p.l.c. is regulated by the Central Bank of Ireland

The Promoter is: AIB Group (UK) p.l.c. (on behalf of the Fund Provider), registered in Northern Ireland under Company Number NI018800. Registered office: 92 Ann Street, Belfast, BT1 3HH. AIB Group (UK) p.l.c. is authorised by the Prudential Regulation Authority and regulated by the Financial Conduct Authority and the Prudential Regulation Authority.

The Entrant is: the person who nominates a registered charity in line with these Terms and Conditions.

1. Only one application per individual and associated email address will be accepted.
2. Entrants nominating an organisation must ensure a charity number exists in the organisation's name. You can check for the registration number on:

3. Completed nomination forms can only be submitted through the online form on <https://aibni.co.uk/community> and <https://aibgb.co.uk/community>
4. Organisations must be a registered charity in Ireland, Northern Ireland, Scotland or England and Wales to be eligible for receipt of funding.
5. The Promoter accepts no responsibility for entries that are incomplete, illegible or fail to be redeemed by the relevant closing date for any reason.

6. If a charity has been nominated and declared an awardee and the Promoter discovers before the distribution of the funds that for any reason under these Terms and Conditions, or otherwise, an awardee is ineligible to enter the Fund or if the entry should have been declared invalid, the Promoter reserves the right to determine that an awardee is disqualified.
7. Nominations for the following organisations and projects are excluded:
 - a. Organisations that relate to religious or political activities
 - b. Non-charitable activities
 - c. Animal charities where animals are the primary beneficiaries (Exceptions include projects that involve animals where the primary beneficiaries are individuals i.e., Autism assistance dogs or similar examples.)
 - d. Nominations that involve covering core costs such as rent, salaries etc, costs to cover trips abroad and general running or ongoing costs of an organisation
 - e. Retrospective funding (work that has already taken place)
 - f. Nominations for projects with the purpose of promoting sport/ competitive sport
8. All nominated charities are subject to due diligence review and an AML vetting process, and the Promoter reserves the right to monitor beneficiaries' use of funds.
9. No same organisation will be eligible to receive funding for a period of three years following receipt of a grant of funding.
10. The Promoter's current core charity partners cannot be nominated for this Fund. Visit aib.ie/community to see the current list of core partners.
11. Nominations received after the closing date will not be accepted.
12. Personal contact details included on the nomination forms will be held for the duration of the nomination process and will not be used for any purpose other than accepting nominations for the charity partner. Once the process is concluded and a charity partner is awarded, all data collected via the forms will be deleted. 13. No purchase of any product is required to enter.
14. Closing date for receipt of nominations is 19 June 2026 at 5PM.
15. The Promoter can extend or withdraw the process period at any time or change any aspect of the Fund at any stage without prior notice.
16. The Promoter's reviewing panel's decision is final and binding on entrants and no correspondence will be entered into. Entrants acknowledge that there is no right of appeal and they will not have recourse to the Promoter's complaints handling procedures.
17. The funds received by the top six awardees in Greater Dublin, Rest of Leinster, Munster, Connacht and Ulster (ROI) is €20,000. In the Northern Ireland & Great Britain region, there will be seven awardees who will each receive £15,000.
18. For 2026, an additional amount of €60,000 will be made available to the Fund to celebrate Allied Irish Bank, plc's 60th anniversary this year. This additional funding will be allocated equally across the six regions, with €10,000 allocated to each region (£10,000 for Northern Ireland and Great Britain region). In each region, this additional allocation will be awarded to one additional awardee, who will receive €10,000 (£10,000 for Northern Ireland and Great Britain region). Each such additional awardee will be subject to the same terms and conditions that apply to the top awardees.

19. Funding received by the charities must impact the region in which they have been nominated.
20. The awardee may be required to take part in publicity such as photography for use on social media or on the branch screens etc.
21. By entering an organisation to this Fund, entrants are deemed to have accepted these terms and conditions.
22. Following the reviewing process for the final list of charities nominated, the Promoter reserves the right to withdraw charities on the basis of additional detail/information required to ensure they are aligned to the Fund's terms and conditions.
23. These terms and conditions are governed by the Laws of Northern Ireland and by entering an organisation to this Fund you are under the exclusive jurisdiction of the courts of Northern Ireland should any dispute arise as a result of taking part.
24. the Promoter reserves the right to amend, withdraw, terminate the process or alter the specification of the Fund without prior notice.
25. The Promoter reserves the right to vary, cancel or modify the process and/or the Terms and Conditions at any time and for whatever reason and/or amend the process (and/or any related funds) in whole or in part at any time due to unforeseen circumstances. The Promoter is also entitled to vary the funds if, due to unforeseen circumstances it becomes impossible to provide the funds as described or in its opinion, it would be inappropriate in any way.
